NJ Peace Action also urges you to continue lobbying your elected representatives on the following issues:

- * to support a genuine, public investigation into the Bush Administration's handling of intelligence to justify the invasion of Iraq
- * to support appointing a special counsel to investigate the leak of the identity of Ambassador Wilson's wife, instead of leaving the work to Attorney General John Ashcroft's Department of Justice
- * to oppose Patriot Act I and II—Support the Security and Freedom Endured (SAFE) Act of 2003 SAFE revises 4 crucial provisions of the PATRIOT Act—"sneak and peek" searches, secret surveillance of business records, library subpoenas and broad wiretapping.
- * to support H.R.2339, the Voter Confidence and Increased Accessibility Act of 2003, which will guard against electronic voting fraud by requiring a physical record of every vote cast
